Since its inception, Global Steel AG has been engaged in the sale and processing of steel products. The founder and managing director of the company is Ludovit Brösl, Ing.

Ludovit Brösl, Ing. studied metallurgy at the Technical University in Košice, Slovakia. He began his professional career at Východoslovenské Železiarne in Košice as a sales manager. In 1995, he founded his own trading company, Global Steel, which became a member of the German business group Montan Voss Group, headquartered in Munich. This group also included Metalex in Košice, the largest steel service centre in Slovakia.

Currently, Global Steel AG focuses on the sale of metallurgical products in Western Europe, while Global Steel Slovakia primarily operates in Switzerland, Slovakia and other Eastern European countries.

Its business partners include the region's largest steel producers, such as USS Košice, Liberty Steel, VoestAlpine, Metinvest, and others.

Having gained extensive knowledge of the Slovak steel market over nearly 30 years of experience, the company is now highly interested in supplying steel products from Saudi Arabia.

Therefore, Global Steel AG is currently seeking a strong partner from Saudi Arabia who would be interested in supplying their products to European market. Given the reduction in production capacities due to the closure or suspension of operations by several manufacturers in the region, this is an exceptionally favourable time for a new player to enter the Eastern European steel market.
